### Position Rationale

Mainline Construction Ltd. is seeking an experienced Mainline Hoe Operator. Reporting to the Foreman, the Mainline Hoe Operator is responsible for the safe and efficient operation of the construction hoe and to perform duties as assigned to ensuring the work completed is delivered according to contract specifications.

### Position Accountabilities

#### Equipment Operations:

- Operate the hoe and other heavy equipment in a safe and appropriate manner.
- Perform daily maintenance and safety checks on equipment.
- Conduct pre-operational checks on equipment, and clean, lubricate and refill equipment as necessary.
- Work with ground personnel in the excavation and installation process of laying pipe online and grade.
- Ensure trench is excavated to the proper depth/grade.
- Responsible for placement of water, storm, and sanitary sewer pipe in the excavation.
- Follow directions of ground crew regarding craning, gravel placement and grading.
- Cut grade with minimal time spent on excavating to ensure production is on schedule.
- Conduct trench work, which meets OH&S requirements.
- Operate Hoe on public roadways, maintaining proper awareness of one’s surroundings.
- Ensure a sound understanding of the issues involving ground disturbance.
- Be aware of proper rigging of pipe, manhole barrels, etc. and ensure safe work procedures are followed during the lowering of materials into the excavation.



- Perform routine cleaning and maintenance to ensure smooth operation of the Excavator/Hoe.

**Technical Knowledge:**

- Knowledge of excavator and other heavy equipment.
- Knowledge deep utility construction materials, utility construction processes and industry requirements.
- Understanding of computerized controls and electronics.

**Work Environment / Conditions:**

- Out of town travel is required.
- Overtime as required.
- Work is performed in an outdoor setting, which could include inclement weather, heat, and humidity.
- Must be physically able to repetitively lift and carry at least 20 LBS on a regular basis.
- Use of Personal Protection Equipment is required.
- Use of sunscreen, long sleeves, and appropriate headgear is recommended.
- Must comply with the company's drug and alcohol testing requirements.
